TO PARTNER WITH HABITAT, APPLICANTS MUST MEET INCOME REQUIREMENTS, DEMONSTRATE THE ABILITY TO REPAY A MORTGAGE, ESTABLISH A NEED FOR HOUSING AND COMPLETE UP TO 500 HOURS OF SWEAT EQUITY BUILDING THEIR OWN HOME AND/OR THE HOMES OF THEIR NEIGHBORS.

PROGRAMS

HABITAT'S IMPACT EXTENDS BEYOND THE FRONT DOORS OF THE HOMES IT BUILDS AND INTO THE NEIGHBORHOODS IT SERVES. CORE PROGRAMS INCLUDE:

- HOME CONSTRUCTION

HGSF BUILDS AFFORDABLE HOMES WITH TRAINED STAFF, VOLUNTEER LABOR, THE "SWEAT EQUITY" OF PARTNER HOUSEHOLDS, AND DONATIONS OF MONEY AND MATERIALS. HABITAT HOMES ARE SOLD TO PARTNER HOUSEHOLDS WITH NO DOWN PAYMENTS AND ARE FINANCED WITH ZERO-INTEREST LOANS. APPROVED HOMEOWNERS QUALIFY FOR A MONTHLY HOUSING PAYMENT THAT DOES NOT EXCEED 30% OF THEIR GROSS MONTHLY INCOME.

- HOME PRESERVATION

THE HOME PRESERVATION PROGRAM RALLIES HABITAT'S MASSIVE SUPPORT BASE TO REPAIR EXISTING HOUSING FOR AND WITH LOW-INCOME RESIDENTS. THESE ACTIONS HELP UNDER-SERVED NEIGHBORHOODS REMAIN VIBRANT PLACES TO LIVE.

CONSTRUCTION AND FUNDING

HGSF HOMES ARE DESIGNED WITH BOTH AFFORDABILITY AND SUSTAINABILITY IN MIND. HABITAT REDUCES THE COST OF CONSTRUCTION WITH THE USE OF DONATED MATERIALS AND VOLUNTEER LABOR. HABITAT ALSO RELIES HEAVILY ON GRANTS AND CHARITABLE GIVING FROM INDIVIDUALS, BUSINESSES, GOVERNMENT AGENCIES, CIVIC ORGANIZATIONS, FAITH GROUPS AND PRIVATE FOUNDATIONS, AS WELL AS DONATIONS OF LAND, PRODUCTS AND IN-KIND SERVICES. THE ORGANIZATION ALSO STRIVES TO BUILD HOMES THAT ARE HEALTHY, DURABLE, AND FEATURE LOW UTILITY BILLS FOR FUTURE HOMEOWNERS.

CURRENTLY, ALL HGSF PROJECTS ARE GREEN POINT RATED, WITH FEATURES THAT CAREFULLY CONSIDER ENERGY AND WATER CONSERVATION, INDOOR AIR QUALITY, SUSTAINABLE BUILDING MATERIALS, AND PROXIMITY TO PUBLIC TRANSPORTATION.
